IX. MOEC By-law Change

A motion was made and seconded to amend the MOEC by-laws:

That the MOEC By-laws be amended to include a standing committee entitled “Founders Committee” under Article VI, Section 2 and state “Membership eligibility for the Founders Committee is open to any retired executive director who is interested in promoting and advocating for educational collaboratives in the Commonwealth.”

And also that Article VII of the MOEC By-laws be amended by adding a Section 6:

“The duties of the Founders Committee shall be to:

- a. Advise the Board of Directors as requested on organizational priorities and history
- b. Retain the institutional memory and wisdom of retired collaborative executive directors”

The motion passed unanimously 20-0-0.

X. Presentation of FY 10 Budget

Richard Murphy presented the FY 10 Budget, to be approved at the June executive board meeting.

Steve Theall informed the membership that the Special Education Transportation Networks budget amendment did not get into the House budget and is unlikely to get into the Senate budget. Steve hopes districts can get

stimulus money to help them start networks or continue new networks.

Steve Theall informed the membership that the dues formula will not change for next year.
