#### **Welcome and Introductions**

Liz McGonagle welcomed everyone to the first FY21 General Membership meeting.

Additionally, we acknowledged that this will be Nadine Ekstrom's last meeting with MOEC. Nadine has only been with us for a short while but she has been a very involved and engaged member of MOEC. She served on the Collaborative Law Steering Committee, and the Professional Development Committee.

# **Executive Director Report**

Joanne provided a brief overview of what would be discussed at today's meeting.

#### **AESA Update**

Cathy Lawson, Liz McGonagle and Joanne Haley Sullivan remotely attended the AESA Legislative Call to Action from September 29 - October 1. They met with legislative aides in Congresswoman Clark, Congressman Lynch, Congressman Neal, Congresswoman Trahan, and Congressman Kennedy joined our meeting himself. Additionally, they met with aides from Senator Markey, and Senator Warren's offices. The focus was on telling legislators about the work of collaboratives particularly in the time of COVID-19, and the challenges of funding we have faced. They briefed them on the revised guidance we have received from FEMA and how that will limit our ability to fund our needs.

AESA has submitted a <u>letter</u> to the House Leadership regarding the HEROES Act and specifically how it will positively impact our districts.

### **Board of Education Meeting and Approval of the Collaborative Regulations**

At the September Board of Education meeting, the revised <u>Collaborative Regulations</u> were approved.

Business Leaders had a discussion with MEMA Public Assistance and learned there was a change to the recent FEMA Guidance that limited reimbursement of expenses related to COVID-19 as of September 15th. FEMA has tied eligibility for reimbursement to a distinction between "response" and "reopening." As a result, all expenses related to bringing students back to school beginning in September results in all costs and responsibilities being borne by collaboratives when they can least afford it.

All other job-alikes have begun as well.

# **Commissioner Riley**

Commissioner Riley joined this meeting and a presentation to inform him of the work collaboratives have been doing to support our students and districts through the pandemic was shown. Presenters were Joanne Haley Sullivan, Liz McGonagle, Theresa Craig, Fran Rosenberg, and Cathy Lawson. He expressed gratitude for the work of collaboratives and suggested that we remain in touch in the coming weeks about possible funding opportunities.

#### Joan Wade, AESA

Joan Wade presented some examples of how ESA's across the country have partnered with their Departments of Education to support teaching and learning during COVID.

- Bringing people together to have conversations about how to move forward.
- Cooperating with one another; rather than competing.
- Nebraska partnered with the Department of Education and with the Department of Health and the ethanol industry to procure 75,000 gallons of hand sanitizer. Also partnered with FEMA to procure masks (at least 5 per student and teacher). They've also received \$16m worth of equipment (devices and internet access).
- Oregon worked with school districts in rural areas where broadband wasn't available to create correspondence courses very "old school" idea, but this worked.
- Meal distribution was essential for students. ESAs coordinated these Breakfast & Lunch programs, often delivering them to families who needed them most.
- Whatever it takes is what ESAs across the country are doing.
- Diverse Portfolio of Services
  - Technology Support
  - Business Services Support
- The Annual AESA Conference will be virtual with over 80 pre-recorded breakout sessions that will be made available for six (6) months after the conference is ended. There will be three (3) live Keynote presentations.
- AESA offers a variety of webinars, including Business Development Support. Those are found on the <u>AESA website</u>.
